LIST OF COUNTRIES WHOSE CITIZENS ARE EXEMPT FROM THE VISA REQUIREMENT FOR SHORT STAYS

Citizen of the following countries **do not require a Visa** for visits up to a maximum of 90 days, for tourism, or study:

Albania, Andorra, Antigua and Barbuda, Argentina, Australia, Bahamas, Barbados, Bosnia-Herzegovina, Brazil, Brunei, Canada, Chile, Costa Rica, Croatia, El Salvador, Former Yugoslav Republic of Macedonia (FYROM), Guatemala, Honduras, Hong Kong, Israel, Japan, Malaysia, Macao, Mauritius, Mexico, Monaco, Montenegro, New Zealand, Nicaragua, Northern Marianas, Panama, Paraguay, Saint Kitts and Nevis, Serbia, Seychelles, Singapore, South Korea, Taiwan, United States, Uruguay, Venezuela.

LIST OF COUNTRIES WHOSE CITIZENS ARE SUBJECT TO THE VISA OBLIGATION

The European authorities have adopted various measures including a list of countries whose citizens are subject to the Visa requirement.

Citizens bearing ordinary passports of the following countries/regional configurations are subject to Visa obligations:

Afghanistan, Algeria, Angola, Armenia, Azerbaijan, Bahrain, Bangladesh, Belarus, Belize, Benin, Bhutan, Bolivia, Botswana, Burkina Faso, Burundi, Cambodia, Cameroon, Cape Verde, Central Africa, Chad, China, Colombia, Comoro Islands, Congo, Congo (Democratic Republic of), Cuba, Djibouti, Dominica, Dominican (Republic), East Timor, Ecuador, Egypt, Equatorial Guinea, Eritrea, Ethiopia, Fiji, Gabon, Gambia, Georgia, Ghana, Granada, Guinea, Guinea Bissau, Guyana, Haiti, India, Indonesia, Iran, Iraq, Ivory Coast, Jamaica, Jordan, Kazakhstan, Kenya, Kiribati, Kosovo, Kuwait, Kyrgyzstan, Laos, Lebanon, Lesotho, Liberia, Libya, Madagascar, Malawi, Maldives, Mali, Marshall Islands, Mauritania, Micronesia, Moldova, Mongolia, Morocco, Mozambique, Myanmar, Namibia, Nauru, Nepal, Niger, Nigeria, North Korea, Oman, Pakistan, Palau, Palestinian National Authority, Papua-New Guinea, Peru, the Philippines, Qatar, Russia, Rwanda, Saint Lucia, Saint Vincent and the Grenadines, Solomon, Sao Tome and Principe, Saudi Arabia, Senegal, Sierra Leone, Somalia, South Africa, Sri Lanka, Sudan, Suriname, Swaziland, Syria, Tajikistan, Tanzania, Thailand, Togo, Tonga, Trinidad and

VISA TYPES

In general terms, there are two main categories of Visa, depending on the duration of the Visa:

SHORT-STAY VISAS - VISA OF TYPE C.

For visits of up to a total of 90 days, calculated over a period of 180 days. The number of days is calculated from the date of first entry to the territory of the countries of the Schengen area. The Visas in question are called

- Uniform Schengen Visas (USVs, Italian initials VSU) valid for the entire territory of the Schengen countries
- Limited territorial validity Visas (LTV, Italian initials VTL) valid for the territory of one or more Schengen member states but not for all of them. Limited Territoriality Visas are only issued in exceptional circumstances.

WHAT YOU MUST DO WHEN YOU APPLY FOR A STUDY TRIPS AND YOU NEED A VISA

Together with your application, please send us a copy of your passport
We need information from it in order to issue the attendance certificate or send us this information as detailed in your passport:

Pay in full your fees

If you need an attendance certificate which is necessary in order to apply for a tourist Visa, you will need to pay all your fees in advance. According to the EU regulations the total study trip fee must be pre-paid in full for the entire period of visit. As a Teachers Training Organization we need to declare it on your certificate of attendance. In case of Visa denial we shall refund 100% the tuition fees, excluded administration fee − 85 €.

WHICH DOCUMENTS CAN LET & Schooling Group VZW PROVIDE FOR YOU?

In order to receive a tourist Visa you must be enrolled to the study trip. According to the EU regulations the study trip fee must be pre-paid in full for the entire period of trip.

We can issue following documents for you:

Certificate of attendance

This documents is a proof of enrolment or pre-enrolment in a study trip, duration of the study trip and global fees paid for it.

Certificate for accommodation

If the accommdation is reserved through the LET & Schooling Group VZW, where applicable , these documents are provided by us.

Flight tickats

If the flight tickets are reserved through the LET & Schooling Group VZW, where applicable, they will be provided by us.

If you wish to have the original certificates of enrolment and school documents necessary for Visa application sent by express courier DHL this can be done at an extra charge.
